The conflict between Israel and the Palestinians has continued for over 100 years and has eluded a peace settlement. Since the 1967 Arab-Israel war, the United States has been active in advancing ideas and promoting peace negotiations. Significant issues divide the parties, including borders, security, refugees, Jerusalem, settlements, and governance, among others. Differences over narratives – historical and current – make it challenging to find common ground. This seminar will examine the conflict and the conflict resolution process, focusing on the narratives of Israelis and Palestinians and on U.S. policy. Students should emerge from the course well-versed in the intricacies of the Palestinian-Israeli conflict and the conflict resolution process.

Grades:

Grades will be based on weekly reading responses (20%), class participation (20%), and three take-home assessments (20% each).
