

# UPDATE ON CHANGING THE RISK PARADIGM FOR U.S. DIPLOMATS

At the beginning of the year, the Academy completed and published its report on Changing the Risk Paradigm for U.S. Diplomats. The report, produced in partnership with the Una Chapman Cox Foundation, details the problem of heightened risk aversion at U.S. diplomatic missions overseas (particularly the high-threat ones) and its implication for diplomats' ability to execute U.S. national security policy objectives. proposes three concrete steps to address the issue: amending the Accountability Review Board (ARB) legislature, adding tradecraft



training for Foreign Service and Diplomatic Security officers, and transforming State Department culture vis-à-vis risk. To launch the report, the Academy partnered with the Brookings Institution in a <u>virtual event on February 29</u>. The event featured Academy members Alonzo Fulgham, Anne Patterson, and Greg Starr and was moderated by General John Allen and Ron Neumann. The panel reviewed the report's findings and recommendations, particularly that of new legislation governing the ARB and assessed how to shape a more resilient and flexible Foreign Service. *(Continued on p. 2)* 

# NEW PROJECT ON MULTILATERAL DIPLOMACY

The Academy's newest project on Multilateral Diplomacy kicked off on March 9 with the first Advisory Group meeting. The project, implemented in partnership with the Una Chapman Cox Foundation, seeks to produce a report that makes the case for the need to strengthen the State Department's policy commitment to and operational capacity for conducting multilateral diplomacy in order to successfully achieve priority U.S. foreign policy objectives in the coming decades. Since the initial meeting, Jo Ellen Powell has been conducting interviews with current and former USG officials, gathering information on best practices by other diplomatic services, and gathering case studies to be examined in the report. # UPDATE ON CHANGING THE RISK PARADIGM FOR U.S. DIPLOMATS

In parallel, the Academy continued its outreach about the issue on the Hill, in the State Department, and to the general public. On the Hill, the Academy has maintained regular contact with the offices of Senator Murphy (D-CT) and Senator Risch (R-TX), both of whom recently introduced separate draft bills to amend the ARB. While both drafts draw heavily on the recommendations and the legislative language proposed in the Academy's report, they also have some differences, and the Academy has continued to push for bipartisan consensus. Representative Sara Jacobs (D-CA) on the House Foreign Affairs Committee is currently working on another version of this legislation, which would potentially combine some of the aspects of both Senate drafts and create a framework for a bipartisan effort. In the meantime, the Academy has reached out to the offices of 13 other Senators and 8 Members of the House of Representatives in order to increase awareness, encourage bipartisan action, and solicit advice about the strategies for effectively pursuing the implementation of the ARB reform recommendation.

The Academy also made a concerted effort to discuss its report with the leadership at the State Department and will continue to do so in the near future as more top leadership positions become confirmed by the Senate. Additionally,

several mid-level FSOs reached out to the Academy to talk about the report. To-date, everyone at State with whom we discussed the report expressed strong support.

Finally, following the report's publication, the Academy initiated a concerted public awareness campaign to promote the report. In addition to the launch event at Brookings, which attracted more than 500 attendees, Ron Neumann and Greg Starr published an article about the report in the Foreign Service Journal and an op-ed on the issue in The Hill. Greg Starr also spoke about the report on Government Matters and will present on it at DACOR Bacon House on July 7.

## RENEWED COMMERCIAL DIPLOMACY EFFORTS

Since the publication of Part II of the *Support for American Jobs* report, AAD has been looking for opportunities to implement its proposed recommendations. Under the last Administration there were not very many such opportunities, although AAD did successfully include some of its proposals into the *Championing American Business Through Diplomacy Act*, which passed as part of the Omnibus spending bill at the end of 2019. There is a hope that the new Administration will be more receptive to promoting the interests of US companies abroad. Consequently, the Academy has reinvigorated its commercial diplomacy efforts. The newly formed Commercial Diplomacy Working Group, cochaired by Shaun Donnelly and Craig Allen, is looking to push for an "all of government" focus on the issue, which would encourage collaboration between State, Commerce, USTR, NSC and other agencies. Several members of the Working Group are also revisiting FSI's efforts to enhance commercial diplomacy training for FSOs.

#### CONGRESSIONAL ENGAGEMENT

In addition to amending the ARB process, the Academy's Congressional Committee, spearheaded by Mike Van Dusen and Graeme Bannerman, continued to engage on the Hill and provide input on various issues that related to U.S. diplomacy. Some recent examples include issues connected to diversity and inclusion, professional diplomatic training, ambassadorial qualifications, commercial diplomacy, consular funding, paying State Department interns, and others.

This year's Ambassadors Forum at University of Michigan will take place on **December 8-9**. Moderated by Ronald Neumann, the panel composed of Craig Allen, David Shear and Sylvia Stanfield will explore *China*, *Strategic Challenges Old and New*.

## **PODCASTS**

Since acquiring new funding, *The American Diplomat* and *The General and the Ambassador* podcasts have continued to explore new topics while actively growing their listener base, collectively reaching more than 400,000 downloads and releasing 211 episodes to-date.

#### American Diplomat Podcast

The *American Diplomat* podcast, now funded by Texas A&M University, and the American Foreign Service Association, with additional funding from the Replogle Foundation, the Delavan Foundation, and the Sisco Family Fund, has explored the stories of the evacuation of Americans from Wuhan, China at the start of the Covid-19 pandemic, combating anti-Blackness in the Foreign Service, online onboarding as a new Foreign Service Officer and tracking dirty money. Having produced 25 episodes since the start of the year, American Diplomat has reached a total of nearly 394,000 downloads, an increase of more than 100,000 downloads since the end of last year.

#### The General and the Ambassador Podcast

The General and the Ambassador has now produced 60 episodes in total and has just surpassed 72,000 unique downloads. In January, The G&A podcast began a 6-month pilot program in collaboration with the University of North Carolina – Chapel Hill, which aims to integrate the podcast into the classroom curriculum to complement their Peace, War and Defense major. As part of the pilot, students from the Transatlantic Security course first listened to an episode titled "Tough Times in Moscow," and then got a chance to engage with one of the episode guests, John Tefft, for a real-time discussion on the future of US-Russia relations. The initial pilot received great reviews from faculty and students, and the Academy's partnership with UNC-Chapel Hill just got a 6-month extension.

In addition to the direct classroom engagement effort, *The G&A* podcast continued to produce new episodes this year, welcoming new distinguished guests this year, such as General George Casey and Ambassador John Negroponte on Iraq and the U.S. Diplomatic-Military partnership and Ambassador to Ken Braithwaite and Commander Jamie Foggo on U.S. power and presence in the Arctic.

The podcasts have continued to prove themselves invaluable resources in advocating for and informing the general public on the importance of American diplomacy.
